

The year 2002 was full of issues, both political and in the field. Several court cases involving NPDES permits and the Clean Water Act were in progress at the printing of this newsletter. On December 3rd, 2002 the New York Times reported that a New York judge dismissed a case involving the Clean Water Act. The year 2003 should bring successful resolution to the open cases and hopefully, assure aquatic plant managers that applications in accordance to the label will not need a NPDES permit.

We saw some new technology emerge in 2002. The biggest news for aquatic plant managers was the Florida aquatic registrations coming in 2003 for two herbicides. SePRO should have a Florida aquatic registration for Renovate in early 2003. Renovate is an amine formulation of triclopyr. BASF was waiting for EPA to issue an aquatic label for imazapyr, which should be available in 2003. We need all the tools we can get, so hats off to SePRO and BASF.

As the title states, "move forward," and I will be doing just that. Most of you know the secretary position has a term limit of three years, and I have reached my limit (just kidding). I have enjoyed serving the society as secretary and look forward to serving as a director. Angie Huebner will be taking over as secretary and newsletter editor in 2003.

President Rodgers adjourned the meeting at 11:32 a.m.






