The Delegate shall serve a two year term and may serve one consecutive term if ratified by the Board of Directors. The duties of the Delegate shall be to represent the Society at Committee Meetings and to advise the Board of Directors of Committee activities.

#### Article VIII - Committees

Section 1. Chairpersons of the following committees shall be appointed each year by the President of the Society with the advice of the Board of Directors. The duties of these committees shall be as indicated.

Required web site items shall include a list of board members and associated phone numbers, annual conference information with links, membership information and an email link for contact by FAPMS members.
