Old Business

The board discussed some of the cost of Aquatics magazine, president Pontius will review some of the expenses.

Jeff Holland gave an update on the TMDL program, Jeff reported the Attendees were informed that while every basin may not be issued a TMDL, all basins upstream will be affected by the TMDL BMAP (Basin Management Action Plan) process for Lake Okeechobee. Due to concerns with the Florida Everglades, Florida Legislation is making FDEP speed up the process for Group 4 (Kissimmee River Basin) from 2010 to 2007. The draft "Verified Impairment List" is scheduled to be completed by Sept, 2007, with implementation scheduled by Dec. 2007. Pat Fricano, Basin Coordinator, requested comments from stakeholders who have any questions about this process.

In addition, changes to lake assessment methods by FDEP Bioassessment Department continue forward with the implementation of the Lake Vegetation Index (LVI). If anyone in FAPMS has received more information about the LVI process, the origin of the Conservation of Coefficient" (COC) numbers for each plant, or how this plant list was created please bring this information up to the board. Since both the TMDL and LVI programs are inter-related, there is a potential for aquatic plant management activities to be regulated under the TMDL process much like it was regulated under the NPDES process on the west coast a few years ago.





By-Laws Committee Update

The Society Directors and Officers completed their annual review of the Standard Operating Procedures (SOP) Manual and provided a number of comments and recommended changes to the By-Laws Committee for incorporation into the manual. The updated SOP Manual and By-Laws may be viewed and downloaded in a .pdf file from the FAPMS web site.

The FAPMS web site is located at www.fapms.org. Click on *Information Center* in the left-hand menu on the home page and there you will find the SOP Manual and By-Laws, together with archived .pdf copies of Aquatics Magazine files back to Spring 2004.

Besides numerous typos turned up during the review, the most notable changes to the SOP Manual included:

- Deletion of the Delegate to the Aquatic Plant Advisory Committee and all Committee references since it no longer exists.
- Addition of the Financial Committee to the Committee List. A previous revision had inadvertently deleted this committee.
- Addition of the Web Site Committee, recently added to the By-Laws.
- Clarifications in job descriptions noting that the Offices and Directors-At-Large together comprise the Board of Directors.
- The Directors-At-Large responsibilities changed to Board of Directors, since all responsibilities are shared with the officers.
- Clarification that the President-Elect serves a three-year term: Year 1 as President-Elect, Year 2 as President and Year 3 as Immediate Past President all three are officers and voting positions.
- The Immediate Past President is responsible for coordinating all revisions to the SOP Manual with the By-Laws Committee. (As a note: this year's Immediate Past President [IPP] is Bill Moore and next year's IPP will be Vicki Pontius.)
